Submissions Guidelines

- All submissions must be written in English
- The abstract should not be more than 500 words. It shall be accompanied by a cover letter containing-a brief profile of the author including the e-mail id, contact number, designation, institution, and official address of the author (authors).
- The word limit for a research paper is 8000-9000 words [inclusive of all citations and references].
- Submissions must be typed in Times New Roman, Front size 12 on A4 size paper with 1" margin on all sides with 1.5 line spacing. The heading should be in Times New Roman, Front size 14, Bold, 1.5 line spacing, centre-aligned while sub-heading should be in Times New Roman, Front size 13, 1.15 Line spacing. Footnotes must be in Times New Roman, Front size 10 with 1.0 line spacing. The file extension shall be .doc. [dot doc].
- Authors & Co-authors need to get registered for the seminar
- The Author(s) should send a declaration along with the abstract & final paper that their work is original and unpublished and that it does not infringe the copyright laws. The organizing committee is not responsible for any copyright infringements by the authors or presenter/s and if found the paper is liable to be disqualified at any stage.
- Author(s) are required to adhere to a uniform mode of APA citation styles.
- Few selected papers to be considered for an edited Book subject to checking plagiarism and after blind reviewing.

Registration Guideline

- Every co-author must have to register.
- The registration fee is Rs.700/- per author
- Registration fee for other countries participant US\$ 50 [online]
- The seminar will be in ONLINE MODE in Google Platform
- All payments are to be made online. [Link will be given after acceptance of paper].
- Registration Fee is not refundable.
- Certificate in soft copy for presenter will be given only to the registered paper presenter.
